I (Ofc. M. Lemus #445) was dispatched to the victim's address regarding a disturbing the peace report. Dispatch told me the victim and her ex-boyfriend/suspect are both LASD deputies and he has been fired for stalking her. The victim was told by her agency to report the incident to ESPD.

Upon my arrival, I contacted the victim (Confidential), who told me the following in substance:

The victim and the suspect, Caren Carl Mandoyan, were involved in a dating/intimate relationship for about two years. They dated from about 12/12 to 12/14. During their relationship, Mandoyan became controlling over the victim. He did not want her talking to her cousins, her co-workers and did not want her to attend her briefings at the beginning of her shifts. Mandoyan would call her constantly and keep her on the phone for the majority of her shift. On one occasion, while they were both on duty, he took her unit keys and left. The victim was stranded and unable to respond to a potential call. Mandoyan eventually returned with her keys.

In April of 2014, Mandoyan helped the victim install surveillance cameras inside her apartment for added security. She was able to monitor the surveillance cameras via an application on her cell phone. The victim did not know Mandoyan also installed the application on his phone so he was able to monitor the surveillance cameras. During an argument, he admitted to watching her on his cell phone via the video application. The victim immediately removed the surveillance equipment. Mandoyan would also arrive at the victim's work after being asked repeatedly to stop. The victim received a written reprimand as a result of his constant unwanted visits.

Narrative

On September 1, 2014 at about 1900 hours, both the victim and Mandoyan walked to Rock & Brews in El Segundo for dinner and drinks. While there, they got into an argument and walked back to her apartment. Mandoyan was upset over an unknown reason and called her a liar. Once at the apartment, for some unknown reason, Mandoyan attempted to grab her cell phone and she resisted. He managed to grab the phone from her as he pushed her in the chest one time. The victim was not trying to call 911 when Mandoyan grabbed her phone. Mandoyan also grabbed her by her arms during the argument. He then grabbed her by the back of the neck and pushed her face down onto the couch. She struggled and rolled onto her back. As Mandoyan was leaning over her, he ripped her jeans off her body. He then grabbed her by the neck with one hand (unknown which one) and squeezed. Mandoyan continued to strangle the victim for about 15 to 30 seconds making it difficult for her to breath, but she did not lose consciousness. Mandoyan told her, "Look what you made me do bltch." Victim described him as being in a "Crazed Rage" while he was strangling her. The victim feared for her life and believed she was going to die. She kicked and pushed Mandoyan and he finally released his hold around her

She then ran to the bedroom in an attempt to close and lock the door, but he chased her and kicked it once, which preventing the door from closing, and causing an approximate 6" hole. Mandoyan forcibly entered the bedroom, removed clothes from her closet and began ripping them. When she told him to stop and leave, he left the scene, while keeping her cell phone. About two hours later, she went to look for him to retrieve her cell phone and found him in his parked car at Rock & Brews. When she asked for him to return the phone, he refused. They drove back to her apartment where he calmed down, apologized, returned the phone and left. The victim said she did not call the police because she was embarrassed and did not want to involve their agency. She took photographs of her injuries immediately after he left (see photos attached).

On 12/27/14, shortly after she broke off the relationship, Mandoyan arrived at her apartment. He knocked on the door, but she did not answer and he may have thought she wasn't home. Mandoyan removed the screen off the living room window and attempted to open the window, but was unsuccessful because it was locked. Mandoyan used a broom handle and attempted to open the rear glass sliding door, but was unsuccessful. The victim video recorded this incident on her cell phone. When he realized she was recording his actions, he left.

In January of 2015 (unknown date), Mandoyan arrived at her work in Universal City. She left work early as soon as she realized he was there waiting for her. On her way home, he telephoned her and called her a "whore" and argued with her about where she was going to find a new boyfriend. The victim disconnected the call and entered her apartment. Soon after, Mandoyan arrived at her residence and "pounded" on her front door and window. Mandoyan walked to the bathroom window and opened it. He then climbed halfway inside and threw the shower items that were on the window ledge at her. He fled when the victim threatened to call the police.

On June 21, 2015 she spoke with Mandoyan. During their conversation he asked her about the "Mexican" that he saw leaving her apartment. Mandoyan also told her he heard them having sex in her bedroom. The victim confirmed that she and her Hispanic friend had sex in her bedroom on that date. Mandoyan told her, "I have eyes and ears everywhere, remember that."

Mandoyan was standing at the window, outside of her residence and she believed that he was trying to enter the apartment. Mandoyan eventually left the area.

- Mandoyan following her home from Universal City and gaining entry through the bathroom window
- Mandoyan conducting surveillance and watching the victim walk to Rock & Brews with her date

Based on the following, I formed the opinion Mandoyan was in violation of 273.5(a) PC - Domestic Violence:

- Mandoyan and the victim were in a dating/intimate relationship for two years
- Mandoyan pushed and grabbed her by the arm, leaving a visible injury

On 7-17-15, I (Det. Danowitz #470) was assigned to investigate a 273.5(a)PC report (DR#15-1659).

On 7-20-15 at 0943 hours, Det. Humphrey #451 and I met with the victim regarding the domestic violence report. The victim and the suspect, Caren Mandoyan, are both Los Angeles County Sheriff's Deputies. In April 2012, the victim met Mandoyan when she started her field training program at the West Hollywood station where Mandoyan worked. The victim started dating Mandoyan in December 2012. In February 2013, Mandoyan transferred to the South Los Angeles station. After Mandoyan transferred stations he became very controlling over the victim. The first time the victim realized Mandoyan was controlling was in the summer of 2013 when she went to her family's "river house" and Mandoyan showed up uninvited. During their whole relationship, Mandoyan would call her repeatedly while she was at work, interrupting her duties. Mandoyan did not want her to attend her shift briefings, talk to her partners or assist other deputies on calls while working because he was jealous.

While on-duty in West Hollywood, sometime in the Fall of 2013 (rifd), the victim was in her patrol unit looking at paperwork when Mandoyan came to her location on duty and told her to give him her cell phone. The victim refused to give Mandoyan her phone so Mandoyan took her patrol car keys from the ignition and left the location, leaving her stranded. After about twenty minutes, she called Mandoyan and told him he could have her phone if he brought her keys back. When Mandoyan showed back up, the victim handed him her phone without the battery and Mandoyan gave the keys back to her. Mandoyan returned the phone an hour after taking it.

In April 2014, Mandoyan installed surveillance cameras inside the victim's apartment, at her request. The surveillance cameras he installed could be accessed/viewed remotely via a smartphone application, which Mandoyan downloaded to the victim's phone.

In July 2014, the victim was at home and had a conversation with her cousin on the phone. Later the same day, Mandoyan arrived at her apartment and made comments that indicated he had overheard the entire conversation she had had with her cousin. The victim believed that suspect Mandoyan had accessed the surveillance

While at dinner, Mandoyan and the victim got into an argument and walked back to the victim's apartment with After left the apartment, Mandoyan started arguing with the victim. While the victim was alone in the apartment with Mandoyan, for some unknown reason, Mandoyan attempted to grab her cell phone and she resisted. He managed to grab the phone from her as he pushed her once on the chest. The victim was not trying to call 911 when Mandoyan grabbed her phone. Mandoyan also grabbed her by her arms during the argument. He then grabbed her by the back of the neck and pushed her face down onto the couch. She struggled and rolled onto her back. As Mandoyan was leaning over her, he ripped her jeans off her body. He then grabbed her by the neck with one hand (unknown which one) and squeezed. Mandoyan continued to strangle the victim for about 15 to 30 seconds making it difficult for her to breathe, but she did not lose consciousness. While Mandoyan was strangling her, she believed she was going to die. Mandoyan told her, "Look what you made me do bitch." The victim described him as being in a "crazed rage" while he was strangling her. The victim was able to get Mandoyan off of her and run into the bedroom to get away. She tried to close the door but Mandoyan violently kicked the door, leaving a hole. Mandoyan then went to her closet, pulled her clothes off the hangers, and attempted to rip her clothes. He then left the apartment with the victim's cell phone. Since the victim knew Mandoyan drove to Rock & Brews, she decided to drive around the area to see if she could locate him. She located Mandoyan at Richmond St. and Franklin Ave. The victim found Mandoyan and asked him for her phone and Mandoyan said to go to her apartment. Mandoyan met the victim at her apartment driveway. The victim got her phone back when she promised Mandoyan she wouldn't leave him. After Mandoyan left, the victim decided to end her relationship with Mandoyan.

On 12-27-14, the victim was at her residence when Mandoyan tried to break in. She showed me the video she recorded. In the beginning of the video you hear someone violently banging on the door. When the banging stopped she heard a noise coming from the outside of her sliding glass door. She then recorded Mandoyan attempting to use a broom handle to defeat the lock and enter the apartment. Mandoyan realized she was recording him and he looked at her and said, "Oh really?" Prior to successfully making entry, Mandoyan then left the area.

In January 2015 (unknown date) at 0351 hours, the victim said Mandoyan followed her home and tried to unlawfully enter her apartment through her bathroom window. She was able to record this incident. In this video, the victim repeatedly tells Mandoyan to leave her alone but he continues to try and climb in through the window. When the victim tells Mandoyan that she is going to call the police, he stops and leaves the area. It should be noted, the video was recorded in the dark so you are unable to see Mandoyan.

In February 2015, the victim changed her cell phone number and shared it with some friends and family. The victim shared it with a fellow deputy, the victim's new cell phone number. It was later discovered that gave Mandoyan the victim's new cell phone number. It was later discovered that gave Mandoyan the victim, such as who she was dating.

On 6-15-15, the victim started to receive text messages from unknown phone numbers and believes Mandoyan was the person who sent them. I took pictures of the text messages (see attached). The victim attempted to call the numbers back, but did not reach a person or voicemall. The text message indicated they came through the service "text4free.net."

On 6-21-15, the victim invited Mandoyan to her apartment to talk about everything that was occurring between them. While talking at her apartment, Mandoyan asked her who the "Mexican" was that he saw leaving her apartment. Mandoyan also said he heard them having sex in her apartment. The victim confronted Mandoyan about being outside her apartment and listening to what was occurring inside. Mandoyan stated to her, "I have eyes and ears everywhere, remember that." The victim then told Mandoyan to leave her apartment and he did.

It should be noted the victim informed us she spoke to her	cousin, immediately after being choked
by Mandoyan. The victim also shared the videos that she	recorded of Mandoyan with

The victim said she never reported this abuse to her supervisors because Mandoyan told her he had friends in high positions within the Sheriff's department. Since she believed this statement, she did not believe anything
